## Carolyn,

My sincere apologies for taking the week to respond. I had a meeting with my colleagues in Engineering to discuss next plans and can provide a tentative schedule moving forward.

The adaptive management plan was developed to summarize all the best available data and science we have collected in the past several years and use this information to inform decisions moving forward. Since there are multiple factors that contribute to water quality, and several different methods to control stormwater lakes, this plan looked at the trends in water quality and aligned them with available technologies to address the main problem, nutrients. The "adaptive" part of this plan is important because we want to be able to plan and pivot our management activities depending on the efficacy of the different parts of the plan.

With that, two important findings were: The alum treatment was effective and long lasting in removing nutrients from the water column and that a significant source of nutrient cycling was also coming from the sediment layers.

After talking with my team, Engineering is putting together a proposal that includes water sampling in order and a follow up Alum treatment. We will then analyze the effectiveness of the alum and use findings to schedule additional treatments. This will help may also provide us a timeline and scale of dredge activities — With more effective alum requiring less dredging impacts. With the our adaptive plan, even if it turns out the alum is NOT effective, we would pivot to our dredging plan.

This sampling and alum treatment is projected to being in first quarter of 2024. We will likely take a month or two of background samples, treat, and then adjust as needed.

As to recent data, we do not have any water quality samples since the last update as the contract for sampling ended in July. When sampling to track this alum treatment we will typically ask for a year of sampling to help with establishing trends.

Long term, I am looking into putting Harbor Isle Lake onto a City owned sampling program. Right now the City's abilities to take samples in-house are limited to surface grab samples close to the shoreline. I think Harbor Isle deserves a more detailed sampling regime. This is why it is currently contracted out. So, in the coming year I will be working with our internal Environmental Compliance Division, to get the hardware needed to cost-effectively provide the detail needed to characterize Harbor Isle's water quality effectively.
